VOLUNTARY WAIVER, CONSENT, RELEASE & HOLD HARMLESS AGREEMENT – MINOR PARTICIPANT. PLEASE READ THIS AGREEMENT CAREFULLY. DO NOT SIGN UNLESS YOU AGREE TO THESE TERMS. RIDING IS VOLUNTARY. YOU ARE NOT REQUIRED TO PARTICIPATE.

1. Parent/Guardian Certification

I, the undersigned parent or legal guardian (“Parent/Guardian”), certify that:

- I am the parent or legal guardian of the minor named below (“Minor”).
- I am aware of the nature of this motorcycle event and the Minor’s experience and capabilities.
- I believe the Minor is qualified to participate as a passenger only.
- I will not allow the Minor to operate a motorcycle during this event.
- I will ensure the Minor complies with all safety instructions provided by the ride leader, the motorcycle operator, or chapter officers.
- The Minor will wear appropriate protective gear, including a DOT-approved helmet.
- Neither the Minor nor I have consumed, nor will we consume, alcohol or any substance that could impair judgment or safety.
- If I have any questions about the route, safety briefing, or expectations, I will ask before the ride begins.

2. Assumption of Risk (Parent/Guardian and Minor)

I understand and acknowledge, individually and on behalf of the Minor, that motorcycle riding involves inherent risks, including but not limited to:

- **serious injury or death**
- loss of vehicle control
- collisions with other vehicles, objects, or riders
- mechanical failures
- road hazards, debris, wildlife, or weather conditions
- negligent acts by the motorcycle operator or other riders

I fully understand these risks and have explained them to the Minor. The Minor and I voluntarily assume all risks associated with participating in this ride as a passenger.

3. Release of Liability

In consideration for the Minor being allowed to participate in this event sponsored and/or conducted by:

- **Indian Motorcycle Company**
- **Authorized Indian Motorcycle dealers**
- **The Indian Motorcycle Riders Group® (IMRG)**
- **Granite State IMRG – Chapter 1906**
- **MOMS of Manchester**
- and each of their respective officers, directors, employees, agents, volunteers, and representatives

(collectively, the “Released Parties”),

I, individually and on behalf of the Minor, agree to waive, release, and hold harmless the Released Parties from any and all liability for injury, death, property damage, or loss that the Minor, I, or our next of kin may incur as a result of the Minor’s participation in this event. This waiver does not extend to intentionally wrongful acts by the Released Parties.

4. Indemnification

I agree to defend, indemnify, and hold harmless the Released Parties from any claim, demand, or lawsuit brought by or on behalf of the Minor, or brought by me, arising from the Minor’s participation in this event.

5. Photography & Media Release

I grant the Released Parties permission to use photographs or video taken of the Minor during the event for chapter or dealership promotional purposes without compensation.

6. Governing Law

This agreement shall be governed by the laws of the State of New Hampshire, without regard to its conflict-of-law rules. Any dispute shall be resolved by binding arbitration in New Hampshire under applicable federal arbitration law.

7. Acknowledgment of Understanding

I HAVE READ THIS AGREEMENT CAREFULLY. I UNDERSTAND THAT BY SIGNING IT, I AM WAIVING CERTAIN LEGAL RIGHTS, INDIVIDUALLY AND ON BEHALF OF THE MINOR. I SIGN THIS AGREEMENT VOLUNTARILY.
